5) The customer shall be supplied with a copy of this letter, an extract of the conditions and maintenance schedule, if any, recommended by DNV Product Assurance AS and copy of instructions booklet detailing operation & maintenance of the equipment so as to maintain its safe characteristics.

6) The IS/IEC 60079-17 and IS/IEC 60079-19 shall be followed for maintenance and repair of overhaul of the subject equipments.
